



## SILVIUS MAGNAGO PRIZE

For Scientific Research Projects on South Tyrolean Autonomy

2020 AWARD

### The Topic:

The Silvius Magnago Academy honors the special quality of **scientific research papers** (dissertations, master's theses, and collections of essays) by awarding the Silvius Magnago Prize.

The works submitted must be scientific in nature and concern themselves in depth with **legal, economic, political, sociological, historical, or cultural aspects of South Tyrolean autonomy** – and present new knowledge.

### The Prize:

The Silvius Magnago Prize includes the sum of **5,000 Euro** as well as **a remittance covering printing costs** for the publication of the winning research work in the Silvius Magnago Academy series; it is presented in the form of a certificate during a festive celebration.

### Eligibility:

Individual persons or groups of persons are eligible to participate. The submitted works – preferably in German, Italian, or English – must not be more than two years old.

### Deadlines:

The prize will be awarded for the first time on the tenth anniversary of the death of Silvius Magnago, **on May 25, 2020**. The scientific research papers must be submitted in printed form and as a PDF together with the filled-out and signed form **by January 15, 2020** to the Silvius Magnago Academy (Brennerstrasse 7/A, Bozen / Bolzano).

### The Jury:

The submitted documents will be treated with confidentiality; they will be presented to the jury of experts for evaluation without indication of the identity of the author(s). The jury shall select the winner – and in doing so, can make use of external experts.
