Course Description

The course offers a genuinely interdisciplinary program. Each major research emphasis is represented: (a) introductory remarks on the history of ideas, concepts, problems, traditions, institutions; (b) review of methods of the history of concepts and their applications; and (c) evaluation of the role played by a pragmatic history of philosophy. Students are expected to work towards a thorough preparation and training in interdisciplinary intellectual history that will be the basis of their placement in national and international frameworks dedicated to historic research, cultural administration, and information management. During a four-week program, visiting professors from the Erasmus Universiteit in Rotterdam will contribute to the course offering the perspective of intellectual historians. Introduction, application, and evaluation of case-studies pertaining to (1) the history of ideas, concepts, problems, traditions, institutions; (2) the methods of the history of concepts; and (3) the notion of a pragmatic history of philosophy. Seminal discussion. Active course participation, papers, quizzes, final exam consisting of an oral discussion of one of the texts indicated above.

Course Requirements and Evaluation

The course requirements include the following: class discussion and participation, a 1.500 words paper due on Thursday, Dec. 6, 2007 on a topic of the student's choosing, and a final examination to be first held on Tuesday, Jan. 8, 2008. For the calculation of the final grade, the following formula will be used:

Term Paper:	50%
Final Examination:	50%

Notes and Cautions

The purpose of the papers is both for the student to demonstrate his/her comprehension of a philosophical topic as it is presented in a philosophical text and for the student to engage in thoughtful and critical reflection upon that same topic. In order to fulfill this purpose, the student, after selecting one of the available topics, will find it necessary to consult secondary sources recommended by the instructor in addition to the primary text(s) which are the object of study. But the student should bear in mind that the resulting paper is to embody his/her own ideas and research and should focus on the primary text(s). Furthermore, the student should employ the method of documentation described by Kate L. Turabian's *Student's Guide for Writing College Papers*, 3rd ed. (Chicago: University of Chicago Press, 1976), p. 122-165 to indicate when he/she has borrowed (whether from a primary or a secondary source) from the research or ideas of others.
